**SUPPLEMENTAL DECLARATION OF TINA CHIANGO REGARDING  
REGARDING CLAIM FORMS SUBMITTED BY POTENTIAL CLASS MEMBERS  
IN 303 TRACTOR HYDRAULIC FLUID  
RETAILER CLASS SETTLEMENT AGREEMENT**

I, Tina Chiango, hereby declare under penalty of perjury pursuant to 28 U.S.C. § 1746 that the following is true and correct:

1. I am the Director of Claims Administration, Securities, and Antitrust for RG/2 Claims Administration LLC ("RG/2"), the Settlement Administrator retained in this matter, located at 30 S. 17<sup>th</sup> Street, Philadelphia, PA 19103. I am over 21 years of age and am not a party to this action. I have personal knowledge of the facts set forth herein and, if called as a witness, could and would testify competently thereto. This Supplemental Declaration provides updated information through the Bar Date of December 29, 2021.

2. The deadline to submit a request for Exclusion or an Objection to the Retailer Class Settlement was December 29, 2021. As of January 3, 2022, RG/2 had received 20 Requests for Exclusion prior to (or postmarked prior to) this December 29, 2021 Bar Date.

3. The deadline to object to the Retailer Class Settlement was also December 29, 2021. RG/2 did not receive and was not made aware of any Objections to the Retailer Class Settlement

prior to (or postmarked prior to) this December 29, 2021 Bar Date. Even after the Bar Date, RG/2 has not received or been made aware of any Objections to the Retailer Class Settlement.

4. In addition to the automatic bucket claims, potential Class Members submitted a total of 3,144 Class Membership Forms prior to (or postmarked prior to) the Bar Date of December 29, 2021. Of these, 2,957 were submitted through the online claims portal and 187 were submitted via mail, fax or email.

5. Further, Class Members submitted a total of 651 Request for Correction Forms prior to (or postmarked prior to) the Bar Date of December 29, 2021. Of these, 189 were submitted through the online claims portal and 462 were submitted via mail, fax or email.

6. Finally, Class Members submitted a total of 1,850 Repairs/Parts/Specific Equipment Damage Claim Forms prior to (or postmarked prior to) the Bar Date of December 29, 2021. Of these, 738 were submitted through the online claims portal and 1,112 were submitted via mail, fax or email.
